

He is in the process of a "rotational internship," working with originations/acquisitions, debt asset management, and equity asset management.

He is assisting the team in underwriting and managing real estate investments. Brendan has gained a lot of exposure to the investments side of real estate and looks forward to applying his experience and knowledge learned to his real estate classes as he returns to Storrs in the Fall for his senior year.

As a real estate finance intern on Cigna's Global Real Estate team, Donald Torre has worked closely with Cigna's 200+ properties. He has provided financial analysis through the creation of models and forecasts, which pay close attention to components such as operating expenses and depreciation. Through this, Donald is able to recognize trends in the portfolio and report findings to management. Donald's financial analysis also plays an important role at the project management, transaction management and lease administration levels, ultimately to help make the best financial decisions for Cigna. His team works closely with CBRE to locate buildings suitable for office space, call/claim centers, clinics, pharmacies, etc. Once a site is located, Cigna's real estate



team will acquire capital, if necessary, to build out the space and purchase furniture to suit the business's needs. In addition, the team may acquire capital for building improvements. This may be for tenant improvements, based on the lease they are in, or for infrastructure projects to increase the useful life of the buildings they own. Donald has enjoyed his internship and has gained valuable understanding of corporate real estate.


## Student Intern Spotlight: Fitch Ratings

This summer, Michael Rosenthal and Ryan Flint are working with Fitch Ratings in their Commercial Mortgage-backed Securities Department in downtown Manhattan. Michael and Ryan were given the responsibility of underwriting cash flows for multiple properties within a pool of mortgages comprised into a commercial mortgage backed security. The process includes in-depth analysis of quantitative and qualitative data, recent and historical data, bond-issuer underwritten data, comparable property data, appraisal, and budgeted data. In addition, Michael and Ryan perform market research and provide analysts with information necessary to complete a rating on a deal. They are gaining a great understanding of the national real estate markets as they underwrite loans from across the United States. Michael will spend the rest of his summer working in Corporates on his rotation and Ryan will continue in CMBS.

Ryan and Michael are thoroughly enjoying their summer in New York and hope to see more Huskies make their way to the Big Apple. The two will be seniors this fall and are majoring in Real Estate and Urban Economic Studies.

He is in contact with appraisers and loan officers on a daily basis. Since joining, he has worked on properties valued at over \$50 million.

Sean says, "The hands on experience I have gained from this opportunity is indispensable and will travel with me for the rest of my real estate career." This fall, Sean hopes to continue to work part-time for Webster Bank during his senior year.
