To date, Andrew and Kevin have developed and refined the entire life cycle of the Business Development process. The initial marketing efforts were focused on researching verifiable sources of data to compare the value matrix of



the 3 distinct MSA's: Boston, Hartford, and NY. From the understanding and interpretation of this data value matrix they created an interactive digital presentation to present to prospective customers highlighting the Live Work Play experience in the 3 cities. This digital presentation may be discussed in person during a prospective road show or sent as an introductory e-mail link to various C-suites or decision makers. Once the presentation is

complete, efforts are turned to find these prospective customers that would benefit from the Shelbourne Hartford experience. They analyze CoStar to query the data and compile a targeted list of possible customers. Currently, the focused is on creating a matrix of prospect questions and the resulting portfolio specific answers to potential Requests for Proposals from the pool of prospects.

Andrew and Kevin's work so far has been a part of Shelbourne's expansion and growth into the Hartford market. Andrew and Kevin are grateful for the industry insight and experience that Shelbourne has provided them with and look forward to what the future holds.
